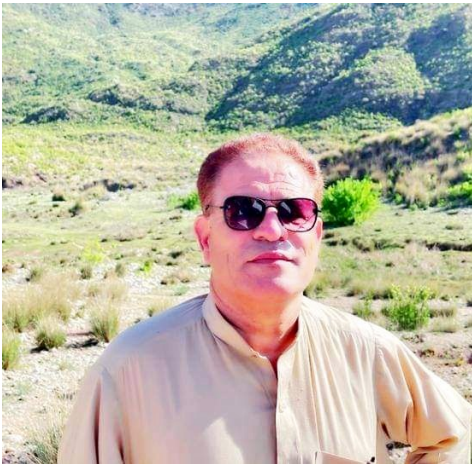
MOL Pakistan Sponsors Cricket Tournament in District Karak

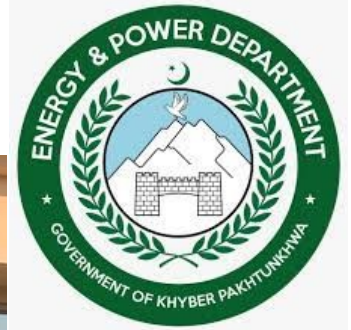


Provincial Government Officials Visit MOL Pakistan's Central Processing Facility

MOL Pakistan hosted the visit of the following provincial stakeholders of the Government of Khyber Pakhtunkhwa at the Central Processing Facility (CPF):

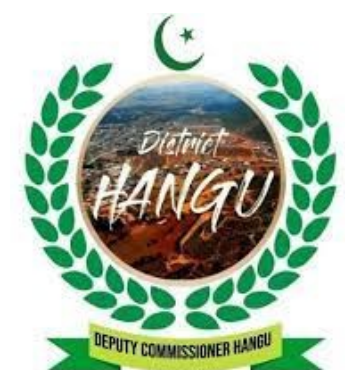
- Mr. Tashfeen Haider, Special Secretary, Energy and Power Department
